I am writing to introduce myself to you and express my interest in being appointed to the interim School Board Seat vacated by Ms. Marshall last week. Ms. Marshall served the Board and the Tuckahoe District with great commitment and integrity for many years and has left a void which will not easily be filled. That said, her vacancy is an opportunity for new voices to come forward to represent the families of the County who are facing issues unlike any with which they have previously dealt. It is my sincere hope to be appointed to the Tuckahoe Seat to represent and amplify those voices.

My husband, James, and I have lived in Henrico for more than 21 years and in the Tuckahoe District for nearly 13. 2 of our 3 boys attend Gayton Elementary and the third will be there soon. Part of my desire to serve grew out of my advocacy for our eldest son, Leo, who has special needs. A well-funded school system sets our children up for future success in a way nothing else can. I want to serve on the School Board to help ensure the continued excellence of Henrico County Schools.

Professionally, I work in Healthcare Administration and earned my Master of Science in Health Administration in 2001. I specifically chose Health Administration rather than a business degree because I wanted to build a career in a profession that could directly improve the quality of people's lives. I currently work for a small company that designs, owns and manages health plans that serve Medicare and Medicaid populations. We are actively improving the quality of our members' lives which is incredibly rewarding.

My experience in this start-up environment has prepared me for being part of a small team and finding ways to compromise to solve problems. Demands shift continuously and I'm often part of different teams of folks with whom I sometimes disagree. My professional success is readily translatable to the School Board environment where the work that is being done contributes to the greater good no matter what my personal interests may be.

Having run for office last year, my family and I are well versed and comfortable with the time I must spend away from them to go to meetings.
